Signing of the co-operation memorandum



Following our common agreement to join the Nordic Regulators group during previous BALTREG Plenary in Tartu (Estonia), SPRK took initiative to organize the inauguration meeting of the group in Riga on 24 May this year.

Goals and operating principles of the MoU and its deliverables



create a closer co-operation between the 8 Nordic and Baltic regulators in the name of the Nordic-Baltic Electronic Communications Regulators Network (NB Reg);

NB Reg will deal with issues related to the Nordic, Baltic and European electronic communications markets and also with exchange of information with respect to developments within each country;

the formation of joint statements and common positions will be driven by the principle of consensus;

the main organisation of NB Reg will be a rotating chairmanship whose appointment will take place every year;

the regulators will appoint contact persons to deal with the exchange of information between the regulators;

the meetings will be held at least once a year physically and the regulators may invite other representatives whenever appropriate to their meetings or other events of common interest.
