- Significant increase (+268%) of meetings via audio-video conference tool (VidyoDesktop)
- 51% less physical meetings (mainly in Brussels)





- Significant increase (+194%) of experts joining meetings via audio-video conference tool (VidyoDesktop)
- 55% less experts participating in physical meetings (mainly in Brussels)





- Travel reimbursements covered by BO are for 53% experts less comparing 1H 2017 and 2018
- Travel expenses covered by NRAs are for 57% experts less comparing 1H 2017 and 2018





Significant increase of AVC, resulted 55% savings of experts travel reimbursements in 1H 2018 comparing 1H of 2017

Simulation of different regulatory / policy approaches based on data from countries (e.g. 3) with different demographics and market structures);
- **Budget** (APPROVAL OF FINANCING DECISION BY MC/BoR IS NEEDED)
 - ➢ Phase 1 ≤150 K€
 - Phase 2 ≤ 400 K€

- Guidelines on a template for General Authorisation notifications and establishment of an EU database of notifications [Code: Article 12]
- Guidelines on geographical surveys [Art 22.7]
- Guidelines on the identification of the point beyond the first concentration point at which interconnection would be commercially viable for access seekers and on the location of the network termination point in different network topologies and other aspects of Article 59
- Guidelines on minimum criteria for a reference offer, to contribute to consistent application of transparency obligations [Code: Art 67]
- Guidelines on the application of criteria related to co-investment offers and voluntary access agreements (possibly starting with a report on the features and market impact of existing voluntary access agreements and co-investment agreements) [Code: Art 74]

Possible changes

EWG Structure

- Some suggestions for amendments:
 - Split mobile and roaming group
 - New group for strategic topics
 - Merge REM & RA & BMK
 - New EWG for numbering and emergency services issues
- Increase cooperation between the EWGs
- More AVC, less physical meetings

EWG work

- External studies only in areas where NRAs have no competences
- Higher level of transparency of the work within the groups
- Strong commitment from NRAs to send experts (drafters)
- More active participation in Art7/7a EWGs (present participation of NRAs in Art. 7/7a Phase-II EWGs is extremely unbalanced (i.e. 19 in 29 for experts, 7 in 29 for rapporteurs))
- More coordination with other bodies , eg. Consumer associations
